

#### SCRUTINIZER'S REPORT ON E-VOTING FOR AMRIT BANASPATI COMPANY LIMITED

30<sup>th</sup> Annual General Meeting of the Members of Amrit Banaspati Company Limited held on Wednesday, the 8<sup>th</sup> July, 2015 at 11.30 A. M. at Hotel Orange Pie, A-1, Sector-66, NOIDA (U. P.) -201 309.

Subject: Passing of resolutions through electronic voting pursuant to section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014.

Dear Sir,

- Pursuant to the resolution passed by the Board of Directors of Amrit Banaspati Company Limited (hereinafter referred to as the "Company") on 14<sup>th</sup> May, 2015 I have been appointed as a Scrutinizer for the e-voting process as mentioned under Rule 20(3)(ix) of the Companies (Management and Administration) Rules, 2014.
- 2. The Company engaged National Securities Depository Limited ("NSDL") as the Service Provider for extending the facility of electronic voting to the shareholders of the Company. The Service Provider provided a system for recording the votes of the Shareholders electronically on all the items of business sought to be transacted in the 30<sup>th</sup> Annual General Meeting ("AGM") of the Company, which was held on Wednesday, the 8<sup>th</sup> July, 2015. National Securities Depository Limited (NDSL) had set up e-voting facility on their website, <a href="https://www.evoting.nsdl.com">https://www.evoting.nsdl.com</a>. The Company had uploaded all the items of the business to be transacted on the website of the Company and also it's Service Provider to facilitate their shareholders to cast their vote through e-voting.
- 3. As on the cutoff date there were 12879 Shareholders of the Company. The Notice of Annual General Meeting and circular for e-voting was sent through email to 1296 Shareholders whose email id was made available by the two depositories and for those holding in physical form to the extent it was available with the RTA and to 11577 shareholders in the physical form. There were 36 incremental shareholders who became member after the despatch of notice. The notice of annual general meeting was sent through email to 20 such shareholders and in physical mode to 16 shareholders.
- 4. The Notice sent both through email and physical form contained the detailed procedure to be followed by the shareholders who were desirous of casting their votes electronically as provided in the Rule 20 of the Companies (Management and Administration) Rules, 2014.

- The cutoff date (Record date) for the purposes of identifying the Shareholders who will be entitled to vote on the resolutions placed for the approval of the shareholders was 01.07.2015. The e-voting facility was kept open from 5<sup>th</sup> July, 2015 (9.00 A.M.) to 7<sup>th</sup> July, 2015 (5.00 P.M.)
- 6. Pursuant to Rule 20(3)(v) of Companies (Management and Administration) Rules, 2014, the Company also released an advertisement, which was published more than five days in advance from the date of beginning of voting period in Financial Express, English Newspaper and in Jansatta, Hindi Newspaper both dated 10<sup>th</sup> June, 2015. The notice published in the newspaper carried the required information as specified in the Rule 20(3)(v) (a) to (g).
- 7. At the end of the voting period on July 7, 2015 at 5.00 P.M. the voting Portal of the service provider was blocked forthwith. On July 8, 2015 after the annual general meeting the votes cast through e-voting facility was duly unblocked by me as a Scrutinizer in the presence of Ms. Varsha Joshi and Ms. Shikha Dixit who acted as the witnesses, as prescribed in sub rule 3 (xi) of said Rule 20 of Companies (Management and Administration) Rules, 2014.
- Particulars of all Votes cast by electronic mode have been entered in the register separately maintained for the purpose in electronic mode.

As a Scrutinizer the report of the e-voting carried by the shareholders was duly complied, the detail of which are as follows.
